

- Govern access rights through integrated Entitlement Review and Self-Service Access facilities, or through integration with existing Identity & Access Management (IAM) technologies
- Monitor and secure Active Directory to prevent unauthorized access to data resources and mitigate risks associated with account compromise and privilege escalation
- Baseline security configuration and highlight high-risk conditions often exploited in breach scenarios across endpoints, Active Directory, and data repositories themselves
